Essay should be original (not published earlier or extracted from other sources) in English, 5000 to 7000 thousand words (Times New Roman, font size 12, 1.5 spacing) including footnotes and references (end note). Title of the page should carry all details like name, affiliation, email id, mobile no. of the participants. Students should also send scanned copy of a valid ID card alongwith the essay.
